UNAUDITED FINANCIAL INFORMATION

On or prior to 30 April 2025, CCOOP Group Co., Ltd., the controlling shareholder of the Company, is expected to announce its unaudited quarterly results for the three months ended 31 March 2025 on the Shenzhen Stock Exchange, which include the unaudited financial information of the Company and its subsidiaries (the “**Group**”) for the three months ended 31 March 2025. In order to ensure that all shareholders of the Company have equal and timely access to the information of the Group, the Company hereby announces the following unaudited financial information.

According to the PRC Accounting Standards for Business Enterprises, the Group recorded unaudited operating revenue of approximately RMB137,000,000, unaudited operating costs of approximately RMB142,000,000 and unaudited net loss of approximately RMB1,928,000 for the three months ended 31 March 2025. The Group recorded unaudited assets of approximately RMB281,000,000 as at 31 March 2025.
